1- BOP Single Ram

o Manual Lock Operated Single Rams BOP 13"5/8 x 10M equipped with pipe rams pipe ram 5" flanged Top & Bottom with 02 end Outlets: One 2"1/16 x 10M Psi with blind flange and the other 4"1/16 x 10M Psi with blind flange

o Internal H2S Trim, manual lock cylinder

o Standard Ring groove Stainless Steel Inlay
