Pressure rating: 5000 PSI

H2S Trim (Nace MR0175)

Top connection and Ring groove API 13"5/8 x 5000 PSI (BX160) flanged or studded

Bottom connection and Ring groove API 13"5/8 x 5000 PSI (BX160) flanged or studded

At least two flanged outlets in the lower cavity; all outlets must be plugged. Lower cavity outlets must be 3"1/8 5K and 2"1/16 5K.

*Complete with : * blind shear rams in the upper cavity*
