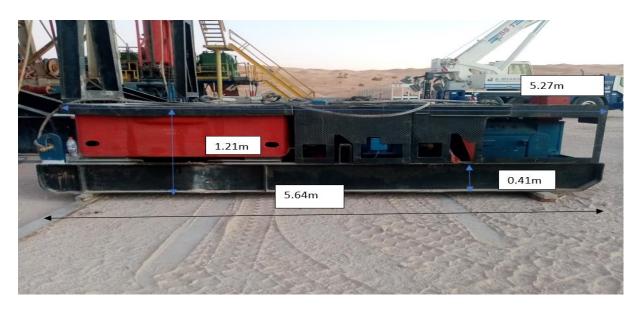

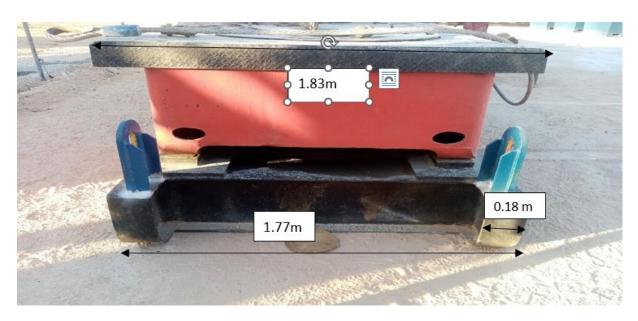

CHAPTER I: GENARAL CONDITIONS

1.1 SUBJECT

The purpose of this contract is to purchase a ROTARY TABLE as described in Attachment A "Technical specifications of the requested parts";

1.2 DURATION OF THE CONTRACT

This contract shall remain in full force and effect for that period of time required to deliver the supplies and render the services as provided in the present contract.

1.3 **EFFECTIVE DATE OF THIS CONTRACT**

This contract becomes effective on the date of signature by both parties.

CHAPTER II: OBLIGATIONS OF THE PARTIES

ARTICLE I: CTF OBLIGATIONS

- 1.1 Bear the cost of customs duties and related expenses of all supplies shipped by the supplier to CTF;
 - 1.2 Appoint a project coordinator who shall have final authority on all matters including any change orders approvals and inspections.
 - 1.3 Make payments as and when due, for contractor invoices as set forth in this contract.

ARTICLE II: CONTRACTOR OBLIGATIONS

- 2.1 Inform C.T.F of any unforeseen event (which would have consequences on the execution of the Contract), immediately upon its occurrence.
- 2.2 Bear all the cost of all duties and taxes outside Tunisia;
- 2.3 Provide documentation required according to API 7k including documents listed in the Attachment A

ARTICLE III: CONFIDENTIAL INFORMATION

All information obtained by the seller during the execution of the present Contract regarding CTF activities shall be kept confidential. CONTRACTOR shall use its best endeavour's to ensure that such information is not divulged.

All commercial information, rates, and prices, provided by CONTRACTOR shall remain confidential and CTF warrant not to disclose any such commercial information, rates, and prices to any third party without the written consent of CONTRACTOR.

ARTICLE IV: ASSIGNMENT OF CONTRACT

CONTRACTOR shall not assign all or part of this contract without the prior written consent of CTF If such CTF's consent is given, then CONTRACTOR shall not be released from any of its obligations set forth in the present Contract and its Exhibits.

CHAPTER III: TERMS AND CONDITIONS OF EXECUTION OF THE CONTRACT

ARTICLE I: MODIFICATION/ VARIATION ORDERS

- 1.1 CTF reserves the right to modify part of the supplies by written notice to SUPPLIER; Any additional material requirement/request shall be subject to an approved variation order between CTF and SUPPLIER.
- 1.2 Related additional cost and delivery will be set forth in an amendment agreement or variation order to be mutually agreed upon prior to initiating any scope of supply in any such variation order.

ARTICLE II: TRANSPORT AND DELIVERY

2.1 DELIVERY

Delivery will be three months from receipt of the purchase order.

Such delivery shall be respected and no delays will be allowed except as provided under Chapitre In case of late delivery delay penalties of 1% per day of the total amount of the concerned **ROTARY TABLE** are to be applied provided that such penalties will not exceed 5 % if the related total amount.

The contractor shall provide and account for at its sale cost and expense the equipment in compliance with the Attachment A.

2.2 Packing and Transport:

2.2.1Packing and marking:

Packing shall be adequate to provide good conservation during handling, bad weather, etc... shall bear the full responsibility for damages resulting from improper packing of material.

 - Parcel number in X/N form (the numerator will indicate the sequential number of the parcel and de denominator the total number of parcels).
- Gross weight of each parcel.

- Dimension of each parcel in form L x W x H (length x width x height)
- Special marking as required for specific materials such as fragile, Top, Bottom etc....

2.2.2 Transport and delivery terms:

CTF will arrange for the transport of materials complete by their own means.

CTF will be responsible for obtaining the importation license and clearing the ROTARY TABLE through customs.

2.2.3 Insurance coverage:

CTF will be responsible for insurance coverage of the risks involved in the transport of the Equipments from F.O.T (ex-SUPPLIER workshop) to CTF Base Km 17 Route de Tunis – Sidi Salah- Sfax –Tunisia in accordance with the provision of incoterms 2020 or latest edition of ICC

However, the supplier shall be responsible for packing, handling, and loading the equipment on the truck.

ARTICLE III: GUARANTEE

3.1 Guarantee

Supplier shall guarantee the VARIOUS MATERIALS against any hidden defects, fabrication or materials defects.

Supplier shall also guarantee the free replacement of any defective item without CTF assuming any liability or compensation.

This guarantee shall also cover any and all costs related to packing and shipment incurred when replacing or repairing defective material whether at a designated location or at CTF Base.

During the guarantee period, the supplier shall make any repairs requested by CTF.

3.2 Compliance

SUPPLIER warrants that all supplies sold hereunder have been produced, sold, delivered and furnished in strict compliance with all applicable API Standards to which supplies are subject. SUPPLIER shall execute and deliver to CTF any documents as may be required to effect or to evidence such compliance. All laws and regulations required to be incorporated in agreements of this character are hereby incorporated herein by reference.

3.3 Quality standards

SUPPLIER shall comply with the standards of quality specified by this contract in addition to those customary in the industry if no requirement is specified.

SUPPLIER shall wherever possible state the quality standards being applied to any workshop or project standards that are not already stated in this contract. CTF shall also ensure that any quality standards that they require, but are not stated in this contract, are

brought to the attention of SUPPLIER prior to any work requiring specific quality standards by CTF, being commenced.

CHAPTER IV: FINANCIAL TERMS AND CONDITIONS

ARTICLE I: CONTRACT PRICES

Contract prices are inclusive of all rights, duties, and taxes applicable outside Tunisia and related to the supplier of the ROTARY TABLE including all costs related to packing, and handling.

1.1 Terms and conditions of contract prices

- 1.4.1 The prices set forth in this contract are final and not subject to any revision.
- 1.4.2 These prices are inclusive of all SUPPLIER direct and indirect costs including the following;
- a) All duties and taxes outside of Tunisia;
- b) Salaries, premiums and benefits, employment and social security costs, income tax of Seller's personnel, etc.....
- c) Overhead and profit costs;
- d) All SUPPLIER insurance except as otherwise provided in this Contract

ARTICLE II: AMOUNT & MONEY OF ACCOUNT.

ARTICLE III: TERMS OF PAYMENT

All SUPPLIER invoices shall be paid by wire transfer to SUPPLIER's designated bank account within 30 days from date of receipt of the following documents:

- -Invoice
- -P.O
- -Preliminary acceptance report of the equipment duty signed.

ARTICLE VI: TAXES

All taxes and duties connected to the performance of this contract and payable by SUPPLIER shall be borne by SUPPLIER while those payable in Tunisia shall be borne by CTF without qualifications.

ARTICLE VII: CONFORMITY

The EQUIPMENT shall be in conformity with the technical specifications set forth in attachment A and in supplier's quote.

CTF reserves the right to call on experts or technicians of it's choice to examine, control and test the EQUIPMENT in view of their acceptance.

In the event the EQUIPMENT turn out not to be in conformity, expert fees will be at supplier's cost even in case of replacement of the rejected EQUIPMENT.

Accordingly supplier will not be entitled to make any claim of what ever nature as a result of incurring above costs.

ARTICLE VIII: LEGAL CONDITIONS

8.1: FORCE MAJEURE

Neither party will be considered as failing to meet its contractual obligations in case such failure is delayed, hindered, or prevented by a case of force majeure.

Force majeure is defined as any unpredictable, irresistible event beyond the concerned party's control that prevents him from meeting part or all of his obligations set forth herein.

Strikes of the supplier 's personnel will not be considered a case of force majeure.

In the event delivery of supplies complete with accessories will be partially or totally hampered due to a case of force majeure, the supplier shall advise CTF within Three (03) days by formal notification of the commencement and end of force majeure as well as the likely consequences on the fulfilment of this contractual obligation.

He shall also provide CTF with credible evidence of the existence and duration of the case of force majeure. CTF reserves the right to evaluate the reasons hampering the fulfilment of the supplier's contractual obligations and to decide whether they are among force majeure cases or not.

The time required to fulfill the supplier 's contractual obligations will be extended by the number of days required to overcome the force majeure case. Should the force majeure case exceed Ten (10) days; CTF reserves the right to cancel the contract by written notice (fax or e-mail).

8.2: DISPUTES AND CONFLICTS

Any disputes related to the interpretation or the execution of the present contract —unless settled amicably by the parties shall be settled by the competent Tunisian court.

8.3 LOSS, DAMAGES:

Supplier is required to replace as soon as possible at his costs and expenses (including all costs involved from ex-works to CTF designated delivery site) any missing items or non conformity of part or the totality of the items

All expenses, fees and taxes of what ever nature and – notwithstanding their amounts- incurred in making such replacements as provided in this article will be at supplier's cost.

8.2 REJECTED MATERIAL

Any material rejected by CTF shall be replaced by supplier at his sole cost and expenses and without compensation, as soon as possible but no later than Seven (07) days from date of rejection notification.
