DRILLING EQUIPMENT CAT III & CAT IV

INSPECTION & MAINTENANCE

1. Service Description:

Provide qualified technicians to carry out inspections and closely supervise the category III and IV maintenance work on drilling equipment.

2. Drilling equipment's description:

The drilling equipment covered by this call for tenders concerns the Drawworks, mud pumps, Rotary table and hoisting equipment detailed in annex 1.

3. Scope Of Work:

The inspection and maintenance category III & IV according to API RP 7L and 8B CTF require that, the decision to perform CAT III or IV maintenance is based on as follow:

- The latest result of the inspection of the previous category
- Operating factors (environment, load cycles, operating time, testing, repairs, and remanufacture).

4. Documentation and records to be provided at the end of service:

- Daily service report and summary report;
- Documentation & Records according to API RP 7L & 8B;
- A list of the replacement parts as well as their specifications and parts numbers and/or equivalent parts numbers;
- In case of repair on primary-load-carrying component, to provide maintenance and repair procedures including welding procedures;
- Certificate of conformity specifying the standard and category of inspection as well as the due date for the next inspection or repair.

5. PERSONNEL QUALIFICATIONS

The qualification of the personnel must comply with the API RP 7L standard.

Evidence of Engineer or technician's qualification should be provided.

CTF accepts:

- Professional Engineers or technicians from original equipment manufacturer (OEM) representatives or other manufacturers of drilling equipment representative.
- Professional Engineers or technicians that they have extensive experience that is documented by experience certificates or training by drilling equipment manufacturers.

NDT-qualified personnel will be provided by CTF as well as qualified welders.

6. Service provider qualification & certification

The service provider must provide with its financial offer the following documents:

In case of a manufacturer: Valid API monogram 7K & 8C

In the case of an inspection and maintenance provider:

- Valid QMS certificate (API Q2 or ISO TS 29001) for inspection and maintenance drilling equipment
- Evidence for qualified personnel according to section #5

By signing this document, the tenderer certifies that he is able to carry out the inspections and supervise the maintenance work of the drilling equipment detailed in the annex-1 in accordance with the specific standards and procedures that in his procession, as well as it has acceptance criteria for all primary-load-carrying components.

7. Measurement tools:

The service provider must provide calibrated Measurement tools specific for each type of inspection.

8. Service location:

In the drilling Rigs in the Tunisian territory or in the workshop of CTF or in CTF subcontractor's workshop in Sfax.

9. Service duration:

The service will be distributed by missions during the years 2023 and 2024 according to the deadlines of the maintenance program and the availability of the Rigs.

The accumulation of days of service will be approximately 70 +/- 10 days including travel days (approximately 03 days round trip for foreigners)

Number of missions: About 06.

10. Billing:

The service provider will invoice the number of working days according to the time sheet signed by both parties as well as the air transport ticket.
